## MENTORSHIP PROGRAM

### Mentee Application – 2019/2020 Cycle

CREW Future Leaders is excited to announce that applications for the 2019-2020 CREW Mentorship Program are now being accepted. Started in 2016, CREW Portland's Mentorship Program was designed to connect young professionals with CREW real estate veterans for the purpose of building relationships; sharing industry best practices, and providing leadership knowledge and mentorship to help advance our mentees' real estate careers. The mentors and mentees will meet monthly from 5:30 pm to 7:00 pm, from September through May, to discuss topics and activities as follows:

- **October 3, 2019** – Kick-Off Meeting – Brainstorming session for future meeting topics and Reverse Speed Networking (mentors rotate, and mentees are stationary).
- **November 7, 2019** – Mentors/Mentees meet in small groups.
- **December 5, 2019** – Full Group Program - Business Development Panel.
- **January 2, 2020** – Mentors/Mentees meet in small groups; discuss predetermined topic.
- **February 6, 2020** – Full Group Program meeting.
- **March 5, 2020** – Mentors/Mentees meet in small groups; discuss predetermined topic.
- **April 2, 2020** – Full Group Program meeting.
- **May 7, 2020** – Building Tour and Wrap Up Event.

Mentor small group discussion topics are TBD. Example topics include: Title & Escrow, The Anatomy of a Deal, Developer/Architect/Broker panels, etc. to help professionals advance their careers. Please note that we strongly encourage you to commit to attending at least five of the eight events to benefit from the program as much as possible. If the upcoming cycle doesn't work for your schedule, please consider applying in the future.

There is no fee to apply. If you are accepted, the fee is \$25.00 for student, \$75.00 for members and \$125 for non-members to participate. As an added benefit for non-members, you will be able to apply your mentorship fee towards a full CREW membership for the year you are in the program.
